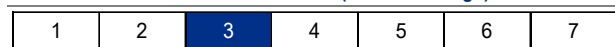

SYNTHETIC RISK / REWARD LEVEL (5Yr vol average)

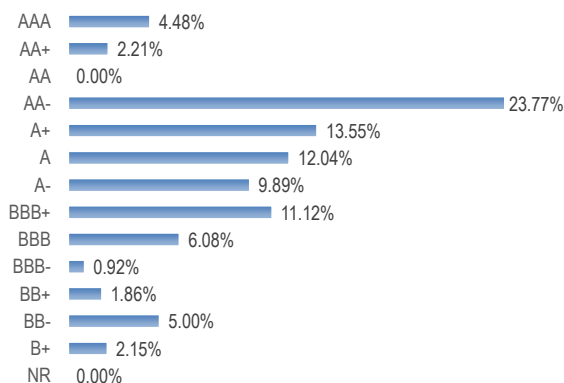

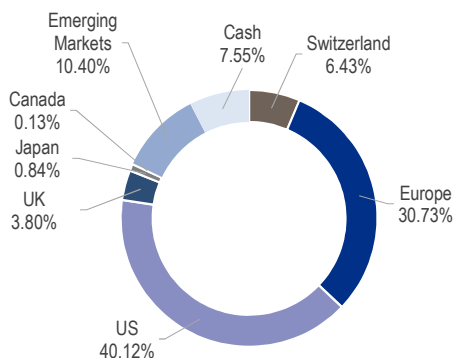

GEOGRAPHICAL BREAKDOWN

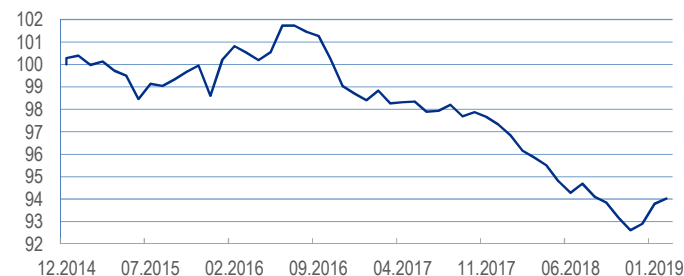
