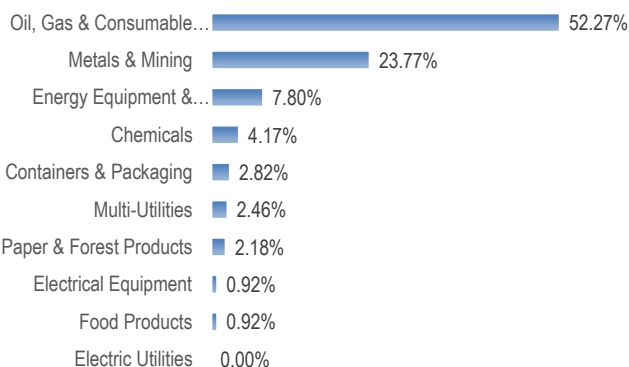

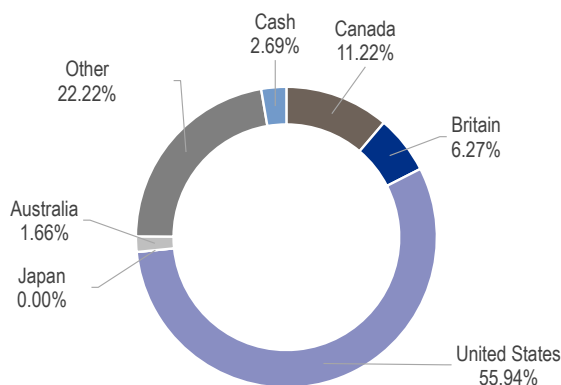

GEOGRAPHICAL BREAKDOWN

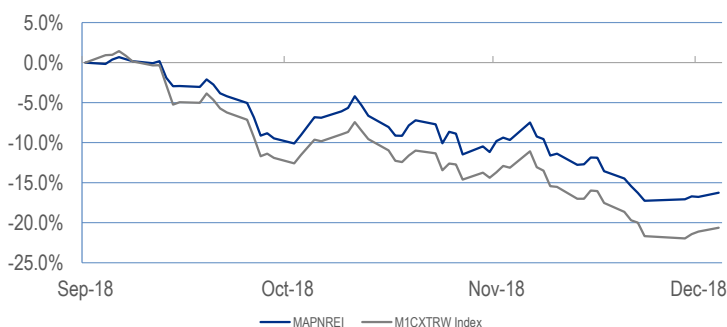
